Department of Pharmacy Practice

Department of Pharmacy Practice (DPP) was established in the year 1997 to evolve the concept of clinical pharmacy through practice and education in India and to focus on the importance of the involvement of practicing pharmacists in patient care. To achieve this, a model 'Clinical Pharmacy Practice Centre' was established at Government District Head Quarters Hospital (GHQH), Udthagamandalam which was first of its kind in the Government sector in India. The clinical pharmacy services to the GHQH, a 420 bedded secondary care hospital and other health care settings of this region achieved significant appreciation from the medical fraternity.

The department has established a 'Drug and Poison Information Centre' (DIC), 'Patient Counseling and Education Centre' (PC) to cater the needs of the other health care professionals and the patient community. The regular activities of the department in the hospital include ward

round participation, patient medication interview, identifying and analyzing drug related problems (DRPs), monitoring adverse drug reactions (ADR), providing drug information and counseling at the bed side, etc.
